Our mission is to build peaceful communities through the power of sport, thereby contributing to a safer, fairer, and more inclusive world. Using a bottom-up approach based on field experience and the realities of local actors, the Organization demonstrates the positive impact of sport in fostering a culture of peace, notably through the *Peacemakers Project*. It raises awareness through various campaigns and initiatives and engages decision-makers from major national and international organizations — whether private, public, sports-related, or development-focused — to expand the use of sport as a tool for peacebuilding.

CONTEXT

Peace and Sport promotes coalition-building and multi-stakeholder approaches in order to leverage the expertise and resources of each partner and ensure the sustainability of its actions. Collaboration with actors from the world of sport is at the heart of this dynamic, from governing bodies to major sporting events, as they serve as powerful platforms for large-scale awareness-raising. Since its creation, the organization has relied on the *Champions for Peace*, high-level athletes committed to peace through sport, who carry its messages and serve as role models on the field. It is essential to support them in their engagement to maximize impact and inspire others to follow in their footsteps.

RESPONSIBILITIES AND MISSIONS

The coordinator actively monitors current developments in the world of sport, identifying best practices and the challenges faced by governing bodies at all levels, as well as by athletes. He/she maintains close relationships with stakeholders in the sports sector and contributes to the development of flagship initiatives, ensuring their impact and long-term sustainability. He/she also supports the strengthening of Peace and Sport's advocacy efforts by showcasing ongoing actions, contributing to the production of strategic content, and engaging sports actors in awareness-raising campaigns.

- Monitoring news related to athletes' social engagement;
- Identifying best practices at both institutional and individual levels;
- Supporting the design, implementation, and sustainability of flagship projects led by Champions for Peace;

- Providing support for the organization of Peace and Sport events, particularly the Forum;
- Offering occasional support on other projects based on strategic priorities and workload;
